

Midrasha Retreat Program

Policies & Cancellation Fees 2016-17

1. Students indicate their intention to attend a Midrasha retreat by responding to an online RSVP form whose link is provided by TV/TC Midrasha approximately six weeks ahead of the retreat date. Late RSVPs (after the RSVP deadline indicated on the form) may be accommodated on a space-available basis. If space is confirmed, the late RSVP will be subject to a \$25 nonrefundable late registration fee.

2. Upon receiving a “Yes” response to the RSVP, TV/TC Midrasha will issue an invoice to the student’s family for any retreat balance that may be due.

3. In order for a student to participate in a Midrasha retreat, the family’s schedule of payments for the school year must be current and any retreat balance must be paid in full by the RSVP deadline. If full payment of balances due is not received by the RSVP deadline, TV/TC Midrasha will remove the student’s name from the retreat roster.

4. Any retreat fees paid to TV/TC Midrasha are nonrefundable after the RSVP deadline, as TV/TC is contractually bound to pay the retreat organizer, Berkeley Midrasha, for any students whose names are on the roster at midnight on the retreat deadline date. **Any student who withdraws from the retreat after the RSVP deadline is fully liable for drop charges that TV/TC Midrasha pays on his/her behalf to the retreat organizer.*** (See *Schedule of Drop Charges for 2016-17 Midrasha Retreats* on p. 2 for detailed information on drop dates and associated fees.)

5. If you would like to switch retreat dates to a later retreat date (for example, you initially sign up for the winter retreat but later decide you prefer spring), you may do so without penalty provided the switch occurs *before* the RSVP deadline for the earlier retreat. Switching to a later retreat date after the RSVP deadline has passed will, in most cases, result in financial responsibility for the earlier retreat.*

**An exception to the “no refunds” policy is that you may be eligible for a refund if another TV/TC student signs up after the RSVP deadline and pays in full for the spot you vacated. Contact the TV/TC treasurer (treasurer@tvtcmidrasha.com) for more information.*

Schedule of Drop Charges for 2016-17 Midrasha Retreats

Fall retreat: November 4-6, 2016 (Camp Loma Mar)

- Before RSVP closes on October 13: No drop charge
- Between October 14 and 20: \$240
- Between October 21 and 27: \$265
- Between October 28 and November 6: \$290

Winter retreat: January 20-22, 2017 (Camp Newman)

- Before RSVP closes on December 28: No drop charge
- Between December 29 and January 5: \$240
- Between January 6 and 12: \$265
- Between January 13 and 22: \$290

Spring retreat: April 28-30, 2017 (Camp Newman)

- Before RSVP closes on April 6: No drop charge
- Between April 7 and 13: \$240
- Between April 14 and 20 : \$265
- Between April 21 and 30: \$290
